NYPD news

New York City Police Department

The PBA is stepping up its public fight with the state Parole Board.

Union officials will now hand deliver letters opposing cop killers' parole to the New York Department of Corrections and Community Supervision until it restores the online service to send in the letters. "DOCCS' Parole Board is clearly not interested in hearing from police supporters or from those who believe that cop-killers should never be paroled," PBA President Patrick J. Lynch said in a statement Sunday. "We will not allow those voices to be silenced or ignored."

Officials at the state Department of Corrections say it has not prevented anyone from voicing their opinion and the union is just looking for special treatment.

"The PBA's most recent attack on the Board of Parole is disingenuous and is effectively a demand for exclusive access to the Board that is not otherwise provided to any other New Yorker," said spokesman Thomas Mailey. "While an e-mail address was made temporarily available for PBA submissions to the Board, that exclusive avenue was discontinued five years ago."

The discontinued program, "Keep Cop-Killers in Jail," was established in 2012 as a way for New Yorkers to object to the paroling of someone convicted of murdering police through the PBA's online tool, which would send a letter to the panel ruling on the person's release.

It was only recently realized by the union that function was shut down after two years, without notice. The PBA says as many as 200,000 letters never made it to the commissioners. In 2018, the union recorded nearly 50,000 letters in protest.

Lynch sent a letter to the DOCCS chairwoman, Tina Stanford, on March 1 demanding the electronic service be restored and has yet to hear back.

"The Board always has – and continues to – accept letters that are electronically submitted through the Department website or submitted by mail," Mailey said.

SBA Responds to Inaccurate Press Reports

Over the past few days, several local newspapers cited "multiple sources" in reporting that a male sergeant assigned to the 75 Precinct engaged in a sexual tryst with his female driver during a mid-night tour. The sources gave explicit details about the encounter and they also stated that the entire incident was captured on a body-cam recording.

After a brief but thorough investigation, this allegation proved to be false and the entire incident was deemed to be a hoax.

The press coverage of this "incident" is an egregious example of irresponsible reporting at the highest levels because the authors made no attempt to substantiate the sordid allegations. I would hope that they put their sources on notice that in the future they will not be taken at their word. All accusations, whether criminal, civil, or administrative, must be corroborated at some level – so the actions of these reporters were extremely reckless and imprudent.

The press, which is supposed to be held to the highest standards of accountability, allowed these buffoons, posing as reliable police sources, to advance its old and tired anti-police narrative. If the press is to be taken seriously when it comes to the reporting of alleged police misconduct, they must start reviewing their own protocol when it comes to taking sources at their word.

I'm sorry that you had to read these despicable articles and I remind you that you are without question the most professional and proficient frontline supervisors in the world.

Widow of cop killed in botched robbery gets \$50K from police charity

The widow of a police officer who was tragically killed during a botched Queens robbery is getting by with help a little help from her friends in blue — in the form of a \$50,000 check.

Leanne Simonsen, 44, whose husband, Detective Brian Simonsen, was killed in the line of duty on Feb. 12, was presented with the check on Friday at her Riverhead home by Blue Lives Matter NYC, a group that helps police families in times of need.

“She kept thanking us and saying how important it was and how special it was and how much it meant to her,” said NYPD Sgt. Joseph Imperatrice, the president and founder of the group. “It’s hard for these families because one day you have a normal life and the next day, you lose a loved one... It’s still fresh, it was five weeks ago and she’s still getting used to the new support system.”

Prosecutors say Christopher Ransom’s robbery of a T-Mobile store in Queens ended up causing Simonsen’s death by friendly fire. Sgt. Matthew Gorman was also wounded during the gunfire.

The money will help Leanne Simonsen get by while she waits for benefits from the city to kick in, Imperatrice said.

“This will definitely give her some peace of mind so at least for the next couple of months she can focus on getting her mind right and whatever she needs to do to heal,” he said.

Imperatrice said Simonsen’s donation, which was presented with help from fellow widow Lisa Tuozzolo, who lost her husband, Sgt. Paul Tuozzolo, in 2016, was the largest donation BLM NYC has presented so far.

Imperatrice said the group raised the money by making and selling memorial T-shirts with Brian Simonsen’s name on it. They sold 7,000 T-shirts in nearly 36 hours and donated 100 percent of the proceeds to Leanne Simonsen.

Judge rules confidential NYPD records will remain secret

A Manhattan judge issued a ruling Tuesday [barring the release](#) of confidential police officer disciplinary records. The order is a major win for the Police Benevolent Association, the officers’ union, which sued Mayor Bill de Blasio, the city, the NYPD and NYPD Commissioner James O’Neill last year after a March 27, 2018, announcement from de Blasio that the city would [begin publishing summaries](#) of officers’ disciplinary records — with names redacted.

Manhattan Supreme Court Justice Arthur Engeron’s Tuesday decision firmly sided with the PBA, saying that the city’s plan to release documents “simply and clearly flies in the face of the law.”

Engeron added the proposal would “enable an agency to circumvent a host of statutory protections belonging to covered officers.” The Law Department said in a statement that they were “disappointed.”

An NYPD spokesman said the department is reviewing its legal options.

City Hall also lamented the decision, and said they would begin working to challenge the ruling through other avenues. The PBA, meanwhile, celebrated the decision as a victory for justice.

Every beat cop in NYPD now has a body camera

Every cop patrolling the city has now been issued a body camera, the NYPD announced.

All beat cops, sergeants and lieutenants — some 20,000 of the Finest — are now equipped, making it the largest body-worn-camera rollout in the nation, said officials, adding that the cameras will “strengthen relationships in the communities we serve.”

“Body-worn cameras enhance the safety and accountability of the dedicated men and women of the NYPD while improving their ability to ensure public safety,” said Police Commissioner James O’Neill. “This completed rollout marks a significant milestone for the NYPD.”

The department also has plans to outfit by August 4,000 officers in the Emergency Service Unit, Strategic Response Group and Critical Response Command.

Cops are required to activate the cameras while conducting “investigative and enforcement actions” such as stopping and questioning someone, searching a suspect, issuing a summons or making an arrest.

“If there’s any enforcement actions at all then those cameras should be on,” First Deputy Commissioner Benjamin Tucker said during a press conference at Police Headquarters Wednesday.

“If you get a radio run and you’re headed to a location, you should have that camera on.”

Officers who fail to do so are subject to retraining — while those who intentionally obstruct cameras face potential departmental investigation, according to officials.

The NYPD adopted the technology in 2017 after a federal judge deemed the department’s stop-and-frisk policy unconstitutional and ordered cops to wear cameras in a bid at improving department accountability.

Since then, police have recorded 3.5 million videos, officials said.

Police could not immediately say how many of those videos have been released to the public — or how many officers have been disciplined for improper use of cameras.

The department retains footage for 18 months and then the videos are deleted, authorities said.

New Yorkers got their first look at body-cam footage in September 2017 following the fatal police shooting of emotionally disturbed, 31-year-old Miguel Antonio Richards in The Bronx.

And there have been growing pains — such as the officer who used another cop’s camera to film genitals inside a police station house.

The department had to yank more than 2,900 VIEVU LE-5 body-cam models last fall after one exploded due to a faulty battery.

Since the rollout, police unions have sued the mayor and NYPD to block the release of camera footage under the state’s Civil Rights Law 50-A, which shields officers’ personnel files.

A judge ruled last month that footage can be made public — but the unions have already pledged to appeal.

JetBlue apologizes for honoring cop killer in Black History Month display

JetBlue paid tribute to a cop killer as part of its Black History Month tribute at JFK Airport's Terminal 5 — and was forced to apologize for the boondoggle.

Joanne Chesimard, also known as Assata Shakur, was featured in the exhibit just past security for 21 days before a flier noticed one of the bullet points describing her prominence in history.

“Became the first woman to be placed on the FBI’s Most Wanted list after escaping to Cuba from prison where she was serving a life sentence for the 1973 murder of a police officer.”

That police officer was New Jersey State Trooper Werner Foerster who was shot dead by Chesimard at a rest stop on the New Jersey Turnpike.

Shakur was described on the poster as a civil rights activist and also read, “Many people believe Shakur to be a political champion who is innocent of the criminal accusation against her.”

An airline spokesperson told the Post the poster was part of a “ready-made batch of posters celebrating Black History” bought from a third-party and “immediately” removed it last Thursday — the same day the image was tweeted out.

The tweet read: “@JetBlue Rumor has it that you are celebrating Black History month at LGA by celebrating Assata Shakur? She is a convicted cop killer. Please tell me this is not true.”

Any mention of the fugitive, who escaped prison in 1977 and took up political asylum in Cuba, often strikes a nerve with law enforcement. The photo in the airport had been circulating pro-cop websites since Monday.

New Jersey PBA President Colonel Patrick J. Callahan said in a statement Thursday, “appreciate Jet Blue removing the portrait of Chesimard out of respect for the Foerster family, the men and women of the New Jersey State Police, and all of the men and women in law enforcement who made the ultimate sacrifice in the line of duty.”

She remains on the FBI’s Most Wanted list with a \$2 million reward and is often brought up in U.S. political relations.

Last year, President Donald Trump demanded the return of Shakur.





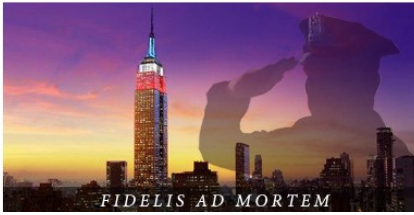

POLICE OFFICER JOSE A. PEREZ Brooklyn South Task Force

Police Officer Jose Perez was killed in a vehicle accident while responding to a call for assistance from fellow officers on Wednesday, April 27, 1994.

As part of an increased police presence in and around Prospect Park in Brooklyn, Officer Perez was on patrol, driving a police van and accompanied by his partner who was in the passenger seat.



At about 1:00 am, members of the 78th Precinct Anti-Crime Team called for additional officers to respond as they pursued six suspects from an assault and robbery which occurred just outside the Park in the Park Slope section. While responding, Officer Perez's patrol van collided with another patrol car that was also responding to the same call for assistance. The force of impact caused the van to strike several parked cars, mount the curb and collide into a stone retaining wall along the perimeter of the park.

Officer Perez was taken to Methodist Hospital, where he died from the injuries he sustained.
