MEDICARE PART "B" REIMBURSEMENT

On Friday, April 12th, most of our Retired members on Medicare received their 2018 Medicare Part B Reimbursement. The 2018 Medicare Part B Reimbursement was electronically deposited into the same bank account in which you receive your pension payment; it will be in the same account shown as a separate deposit from the pension payment. For those members who receive a hard check for their pension payment, you will receive a hard check for the Medicare Part B Reimbursement sent to the permanent address on record at the Pension Section.

For 2018, the standard Medicare Part B monthly cost/deduction was \$134.00 per person per month; \$1,608 for single and \$3,216 for members and eligible dependent. However, for some individuals, the standard reimbursement **amount recently issued by the City** for Calendar Year 2018, was at the 2017 rate of \$109.00 per person per month; \$1,308 for single and \$2,616 for member and eligible dependent.

If you received the standard premium for Medicare Part B reimbursement of \$109.00 per month for 2018, but paid \$134 per month, you can submit to be paid the difference, i.e. \$300/\$600. In order to receive the differential, the retiree and/or eligible dependent must submit a copy of proof of this additional payment (for example, the Form SSA-1099, bank statements, CMS-500 Notice of Medicare Payment Due) to the NYC Health Benefits Program for review. If approved, you will receive the differential payment at a later date; reportedly sometime during the first quarter of 2020. ADDITIONAL INFORMATION:

Member NOT Filing 2018 IRMAA:

If your Medicare Part B Reimbursement was incorrect (you are owed money), and **you will not be filing** for the Income Related Monthly Adjustment Amount (IRMAA), then the member will need to prepare the NYC Health Benefits Program's form "2018 Medicare Part B Reimbursement Differential Request Form"; click here for link to form: <https://www1.nyc.gov/assets/olr/downloads/pdf/health/med-b-differential-form-2018.pdf>. Follow the instructions on the form and provide the requested information. Return the form and the required documentation to: NYC Health Benefits Program Attention: Medicare Part B Differential Unit Church Street Station / PO Box 3478 / New York, NY 10008-3478. We are being informed that these payments will be sent out sometime in the first quarter of 2020.

Member Filing 2018 IRMAA:

If your Medicare Part B Reimbursement was incorrect (you are owed money), but **you will be filing** for the Income Related Monthly Adjustment Amount (IRMAA), then the additional Medicare Part B Reimbursement will be included in your IRMAA payment. The city will automatically adjust the payment and will issue the balance of the Standard Medicare Part B Reimbursement and the IRMAA at the same time, but in separate checks/deposits; reportedly in October. Officials blast parole of Brink's getaway driver Judith Clark

The parole of former Weather Underground radical and Brink's robbery getaway driver Judith Clark is a "perversion of justice" and a "slap in the face" to the families of the cops and guard her accomplices killed, a Rockland County official said Wednesday.

"Today's ruling by the parole board is a cruel and unjust slap in the face to the families of Sergeant Edward O'Grady, Officer Waverly 'Chipper' Brown and Brinks guard Peter Paige," railed Ed Day, executive of the county where the infamous robbery went down. "This perversion of justice is a sad continuation of the deadly assault on police officers happening across our Nation and signals to the criminal element that it is open season on cops."

Clark, joined by three fellow Weather Underground members and six Black Liberation Army members, knocked over a Brink's armored car in Nanuet, NY in Oct. 1981, making off with \$1.6 million and fatally gunning a car guard as well as two responding state cops.

She was sentenced to life behind bars, but in 2016 had her sentence commuted by Gov. Andrew Cuomo, opening the door for her to be selected for early release.

Clark, now 69 and purportedly a model prisoner, was approved for parole by the state board on Wednesday.

"The parole board and the elected officials responsible for allowing this domestic terrorist to walk free should be ashamed," added Day.

Outrage extended to the five boroughs, where Ed Mullins, head of the NYPD's Sergeants Benevolent Association, blasted the decision.

"Welcome to the State of NY, home of Cop Killers who get to walk free," seethed Mullins in a statement. "Thank you Governor for your moronic unethical Parole Board."

BOSTON — A hacker group has posted online the personal information of hundreds of federal agents and police officers apparently stolen from websites affiliated with alumni of the FBI's National Academy. The Associated Press counted at least 1,400 unique records of employees of the FBI, Secret Service, Capital Police, and other federal agencies as well as police and sheriffs' deputies in North Carolina and Florida. The information appears to come from the websites of three local chapters of the FBI National Academy Associates, which claims 17,000 members nationwide. The group's executive director, Howard Cook, said it was looking into whether sites were breached. The AP is not identifying the hackers' website. A linked Twitter account says the group is based in the Ukraine.

Better late than never!

Nearly 18 years after the September 11, 2001 terror attacks, the state DMV is offering a commemorative 9/11 license plate — a remembrance at least 13 other states already have.

The new red, white and blue plates feature the date, 9-11-01, an American flag, and silhouettes of civilians and first-responders standing side by side.

The wording: “Never Forget” and “United We Stand.”

“It’s something that should have been done a long time ago,” said John Feal, an advocate for Ground Zero rescue and recovery workers, who helped DMV staffers design the plates.

Feal said he wanted universal symbols meaningful to anyone affected by 9/11. He rejected a proposed design that included an image of the Twin Towers, because that might cause pain for victims.

“I made it clear I didn’t want anything to bring back bad memories,” he said.

Feal and downtown businessman Neil Pedersen stepped up to the plate last month after The Post reported that the DMV had done nothing to design or produce the plates despite a law signed by Gov. Andrew Cuomo last August authorizing their issuance.

“It was a pretty simple task that seemed to cripple Albany,” Feal said.

Pedersen, owner of Pedersen & Sons Surety Bond Agency, volunteered to put up the \$6,000 bond the DMV said it needed to get the process started. The FealGood Foundation sponsored it.

Pedersen and Feal split the \$120 cost to issue the bond. The \$6,000 will not be necessary once 200 plates are sold.

The DMV set the fees for the plate: Each will cost an initial \$85, and a \$56.25 annual fee to renew an assigned 9/11 plate. For personalized plates, it will cost an initial \$116.25 plus \$87.50 a year to renew

Those renewal fees will be billed every two years in addition to a vehicle’s registration renewal, the DMV says.

Part of the annual renewal fee — \$25 — will support the state’s World Trade Center Memorial Scholarship Fund, which covers college tuition for 9/11 victims, ailing first-responders and their children.

Thirteen other states, including New Jersey and Connecticut, already have special 9/11-inspired license plates, generating revenue for those states’ coffers.



NYPD cop killed in motorcycle crash is dad of 3, including newborn

The NYPD cop whose life was cut short when he crashed his motorcycle on his way to work was a married father of three, including a newborn, police sources said.

Marc St. Arromand, 42, of Long Island lost control of his motorcycle as he was travelling in the westbound lane of the Belt Parkway between Merrick Boulevard and Linden Boulevard in Queens around 5:30 a.m., cops said.

The 16-year veteran — who was assigned to the NYPD's Highway Patrol Unit 2 in Brooklyn — was then ejected from the seat of his 2011 Yamaha motorcycle, police said.

Arromand collided against a metal guardrail and came landed on the roadway where he was struck by a 2017 Gray Chevrolet Camaro driven by a 53-year-old man.

Arromand, who authorities say was wearing a helmet at the time of the wreck, was discovered lying in the left lane of the parkway, unconscious and unresponsive.

He was rushed to Franklin General Hospital in Valley Stream, LI, where he died.

The Chevrolet driver remained at the scene and no arrests were made.

Sources say Arromand had a newborn baby boy and two other sons, aged 2 and 4, with his wife, Cecilia Jackson, who also has a 9-year-old girl and an 11-year-old girl from a previous relationship.

Friends and fellow cops gathered outside of Arromand's two-story home in Elmont hours after his death. "Everyone's grieving right now. His kids are inside. They don't know yet," a cop pal said Thursday afternoon. Neighbor Ralph Cammarota, 84, called Arromand "a terrific guy."

"He was constantly working on the lawn, the house," Cammarota said. "Just a very courteous guy. It's very sad."

Another teary-eyed neighbor recalled how Arromand welcomed him to the neighborhood when he moved in last month.

"He gave me his phone number, said if I need anything, call him," the neighbor said. "He was such a nice guy. I feel so, so bad about this."

NYPD Chief of Transportation Thomas Chan stopped by Arromand's home to give his condolences to the family.

"It's a beautiful family. His kids are just adorable," Chan said outside the home. "His wife is holding up for now, but it's very tough on the family."

Chan said the older children are aware of their father's death, "but sometimes it doesn't hit them right away." "We feel so, so bad. It's a terrible thing," said Chan.

NYC gun owners to get looser rules on moving firearms as NYPD changes policy

The NYPD plans to loosen its rules around gun transportation to allow licensed owners to carry firearms to a second home or a business — instead of restricting them to shooting ranges.

The new rules will apply to places where it's permitted to carry licensed weapons.

Currently the NYPD only allows licensed city gun owners to move their weapons to approved gun ranges or areas where hunting is legal.

Weapons have to be unloaded while being moved and the ammunition must be carried separately. That rule will not change, the NYPD says.

Once the NYPD's new policy goes into effect — following a public comment period — licensed city gun owners will be able to bring weapons with them to a second home or to a business, as well as other places firearm possession is permitted, like a range or for a shooting competition.

The NYPD, which has waged an intense campaign to halt inter-state gun trafficking, described the rule change as important to the legitimate interests of licensed gun owners.

"This change applies only to legal gun owners who have already gone through a strenuous background verification process," Police Commissioner James O'Neill said. "The NYPD's focus will always be on criminals who wield illegal guns, and those who would use guns to cause violence on our streets. Reasonably accommodating the interests of licensed gun owners in transporting their firearms to a legal shooting range or second home strikes a responsible balance between individual interests and public safety."

The change in policy will affect 16,600 licensed gun owners in the city. The 30-day public comment period begins next week and will end in early-to-mid May.

The new proposed policy would not affect gun owners from outside the city. The city has opposed the so-called Concealed Carry Reciprocity Act which would allow licensed gun owners in one state to carry their guns into another state. That bill, proposed by U.S. Rep. Richard Hudson (R-N.C.), has stalled in the House subcommittee on Crime, Terrorism and Homeland Security.





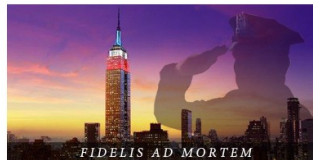
